PGN dan Mubadala Energy Jajaki Potensi Pasokan Gas dari Blok Andaman

Jakarta – PT Perusahaan Gas Negara Tbk (PGN) dan Mubadala Energy South Andaman RSC Ltd (“Mubadala Energy”) akan melakukan kajian bersama terhadap pemanfaatan gas bumi dan pengembangan infrastruktur gas pipa dan/atau LNG dari Wilayah Kerja Andaman Selatan (“WK South Andaman”). Penjajakan ini dilaksanakan untuk menindaklanjuti potensi pemanfaatan gas bumi dari Blok Andaman, yang diresmikan melalui penandatanganan Nota Kesepahaman antara PGN dan Mubadala Energy pada Rabu, (2/7/2025).

“PGN dan Mubadala Energy meyakini adanya potensi untuk berkolaborasi sebagai aksi korporasi dalam rangka eksplorasi dan eksploitasi di WK South Andaman. Pasokan gas dari Andaman pastinya dapat mendukung peningkatan ketahanan energi domestik, seiring dengan kebutuhan gas bumi dalam negeri yang akan terus mengalami peningkatan,” terang Direktur Komersial PGN, Ratih Esti Prihartini, (2/7/2025).

Sebelumnya, kedua pihak juga telah menandatangani Nota Kesepahaman pada tanggal 22 Oktober 2024 untuk melakukan kajian khusus terhadap fasilitas Kilang Arun dan terminal regasifikasi yang ditujukan guna mendukung kegiatan di hulu migas.

“PGN melibatkan peran Anak Perusahaan dan Cucu Perusahaan yaitu Pertagas dan Perta Arun Gas untuk mengkaji kesiapan infrastruktur yang berpotensi dikembangkan dan dimanfaatkan guna mendukung pendistribusian gas bumi dari Andaman ke pelanggan potensial. PGN Group mengedepankan transparansi mengenai data-data yang disampaikan untuk kegiatan wilayah WK South Andaman serta memperhatikan tata kelola perusahaan yang baik (GCG),” ungkap Ratih.

Dengan prospek produksi yang cukup besar, diharapkan dapat mencukupi kebutuhan akan gas bumi di berbagai sektor. Di masa depan, sumber pasokan dari Andaman memungkinkan untuk dimanfaatkan PGN untuk memenuhi demand di wilayah Sumatera sampai dengan Jawa setelah pipa Duri Dumai Medan terbangun, selain itu dapat juga dikembangkan dalam bentuk LNG untuk memenuhi kebutuhan di seluruh area operasional PGN.

PGN and Mubadala Energy Explore the Potential of Gas Supply from the Andaman

PT Perusahaan Gas Negara Tbk (PGN) and Mubadala Energy South Andaman RSC Ltd ("Mubadala Energy") will conduct a joint study on the utilization of natural gas and the development of gas pipeline and/or LNG infrastructure from the South Andaman Working Area ("WK South Andaman"). This exploration is carried out to follow up on the potential utilization of natural gas from the Andaman Block, which was formalized through the signing of a Memorandum of Understanding between PGN and Mubadala Energy on Wednesday, (2/7/2025).

"PGN and Mubadala Energy believe in the potential for collaboration as a corporate action in the exploration and exploitation of the WK South Andaman." The supply of gas from Andaman can certainly support the enhancement of domestic energy resilience, in line with the increasing demand for natural gas in the country," explained PGN's Commercial Director, Ratih Esti Prihartini, (2/7/2025).

Previously, both parties had also signed a Memorandum of Understanding on October 22, 2024, to conduct a special study on the Arun Refinery facility and the regasification terminal aimed at supporting upstream oil and gas activities.

"PGN involves the roles of its Subsidiaries and Affiliates, Pertagas and Perta Arun Gas, to assess the readiness of infrastructure that has the potential to be developed and utilized to support the distribution of natural gas from Andaman to potential customers. PGN Group prioritizes transparency regarding the data provided for activities in the WK South Andaman area and pays attention to good corporate governance (GCG)," Ratih stated.

With a significant production prospect, it is expected to meet the demand for natural gas in various sectors. In the future, the supply source from Andaman is expected to be utilized by PGN to meet the demand in the Sumatra to Java region after the Durian-Dumai-Medan pipeline is constructed. Additionally, it can also be developed in the form of LNG to meet the needs in all areas of PGN's operational regions.

"This agenda is an important step towards comprehensive cooperation regarding the utilization of gas from WK South Andaman.
